

The project components include approximately 2,000 new beds for undergraduate students, an approximately 1,200 space parking structure, two academic buildings, eight classrooms and 600 seat lecture hall, a campus/community craft center, support and gathering space including music and multi-purpose rooms; dining space including a market, coffee shop; retail space.; bike storage; and other support amenities.

name suggests, the project aims at facilitating living and learning neighborhood synergies between academic departments and students living on campus.

The project is being proposed to address a number of campus needs – the shortage of available on-campus housing, as well as the shortage of academic and administrative space, as construction of new facilities has not kept pace with the evolution of academic priorities and enrollment growth.

2018 LONG RANGE DEVELOPMENT PLAN UPDATE OPEN HOUSE

The University of California, San Diego (UC San Diego) is in the process of updating its Long Range Development Plan (LRDP) for the La Jolla campus, previously adopted by The Regents of the University of California in September 2004.

The 2018 LRDP Update will address anticipated growth in student enrollment and associated expansion of faculty, staff, academic and ancillary programs in the context of UC San Diego's Strategic Plan. It is anticipated that UC San Diego could experience an increase in regular academic year student enrollment and associated growth in staff/faculty of approximately twenty-five to thirty percent by the Year 2035. This increase would exceed the population assumptions in the 2004 LRDP and its Program Environmental Impact Report (EIR). Accordingly, UC San Diego will update the LRDP and prepare a new Program Environmental Impact Report (EIR) to address the effects of this growth.
