**Project Description:** The UC San Diego 2018 Long Range Development Plan (LRDP) for the La Jolla campus provides an updated land use plan to guide future physical development. The 2018 LRDP plans for a projected student enrollment of 42,400 at UC San Diego by the 2035-36 academic year. The 2018 LRDP plans for as much as 8.9 million gross square feet of new space to accommodate the programmatic needs of academic, research and other supporting university uses in support of projected enrollment growth.
